CDE's "CA Meals for Kids" mobile app has been updated to help students and families find meals during COVID-19-related emergency school closures. We know you are very busy, but whenever possible, we need school districts to continue to update the Child Nutrition Information and Payment System, which will then populate the meal site locations into the app. We are still instructing families to contact you for availability in their area until this app is fully populated.

CDE has extended the certification deadline for the Fall 2 submission from March 20, 2020, to April 24, 2020.
