- Cal. Govt. - B. Motion to allow the Governing Board to meet in closed session pursuant to Government Code section 54957 which must be agreed to by a two-thirds vote of the members of the Governing Board, or, if less than two-thirds of the members are present, by a unanimous vote of the members present. If authorized, the Board will adjourn to closed session.
