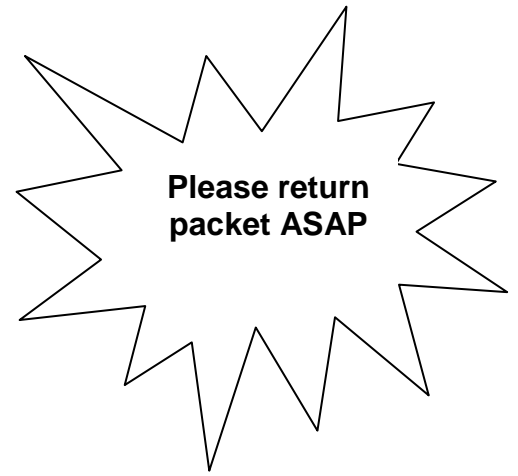

2011/2012 INTERDISTRICT CONTRACT

As a student residing in another school district and requesting a transfer to Pleasant Grove Joint Union School District, I agree to meet the following standards in order to maintain my enrollment in the district.

1. Maintain a 2.0 grade point average, both cumulatively and for each trimester I am enrolled in Pleasant Grove School District. Receive no 1's (failing grade) on my trimester report cards.
2. Arrive at school on time and maintain a 95% attendance rate (no more than 3 days absent) for each trimester I am enrolled unless there is a medical reason explained by a note from a doctor.
3. Practice good citizenship with no suspendable offense each school year I am enrolled at Pleasant Grove School.
4. Follow all classroom and school rules established by teachers.

We understand that:

1. Student must be released from their district of residence.
2. Parents must provide transportation.
3. There is reason to believe that the educational needs of the students can be met at Pleasant Grove School, better or more conveniently than at the district of residence, without unusual expense to PGJUSD.
4. Whenever the School Board believes that the interdistrict attendance is no longer in the best interest of Pleasant Grove School or any of its students, the agreement may be terminated immediately. Interdistrict attendance is at the sole discretion of the School Board.
5. The additional enrollment will not cause the class size in the grades concerned to rise above the district standard.
