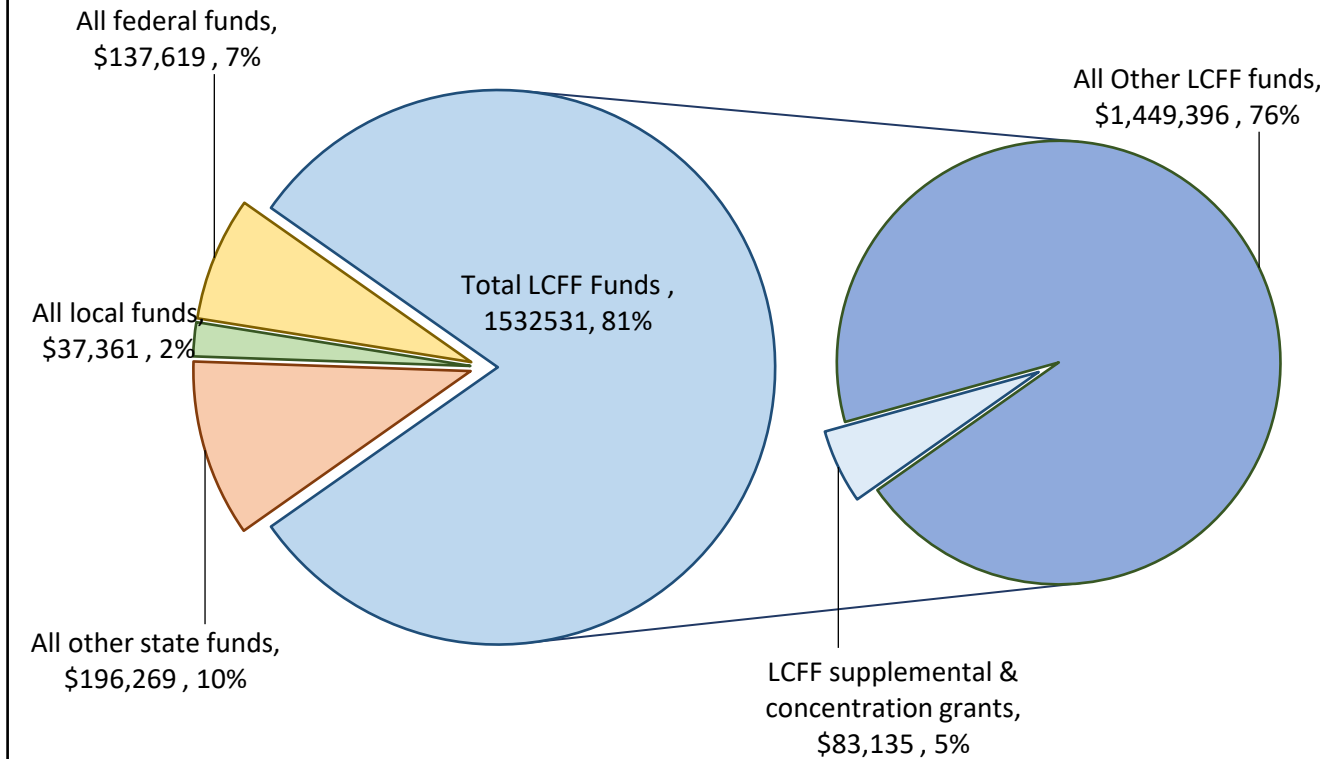

Projected Revenue by Fund Source

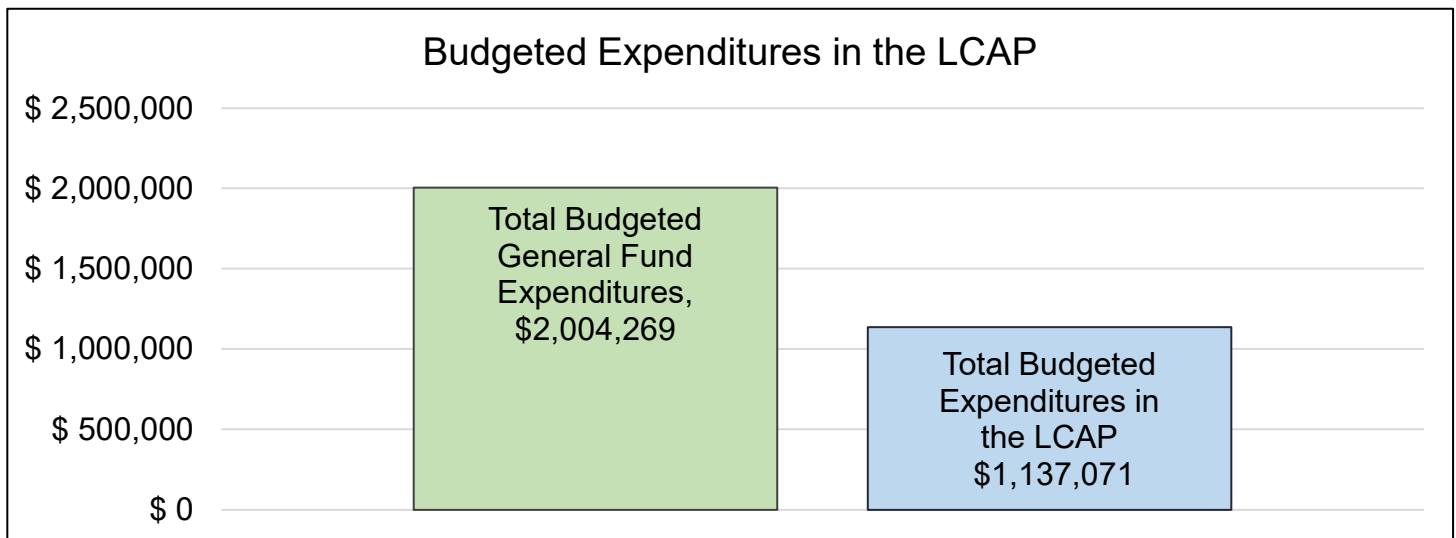


This chart shows the total general purpose revenue Pleasant Grove JUSD expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Pleasant Grove JUSD is \$1,903,780.00, of which \$1,532,531.00 is Local Control Funding Formula (LCFF), \$196,269.00 is other state funds, \$37,361.00 is local funds, and \$137,619.00 is federal funds. Of the \$1,532,531.00 in LCFF Funds, \$83,135.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

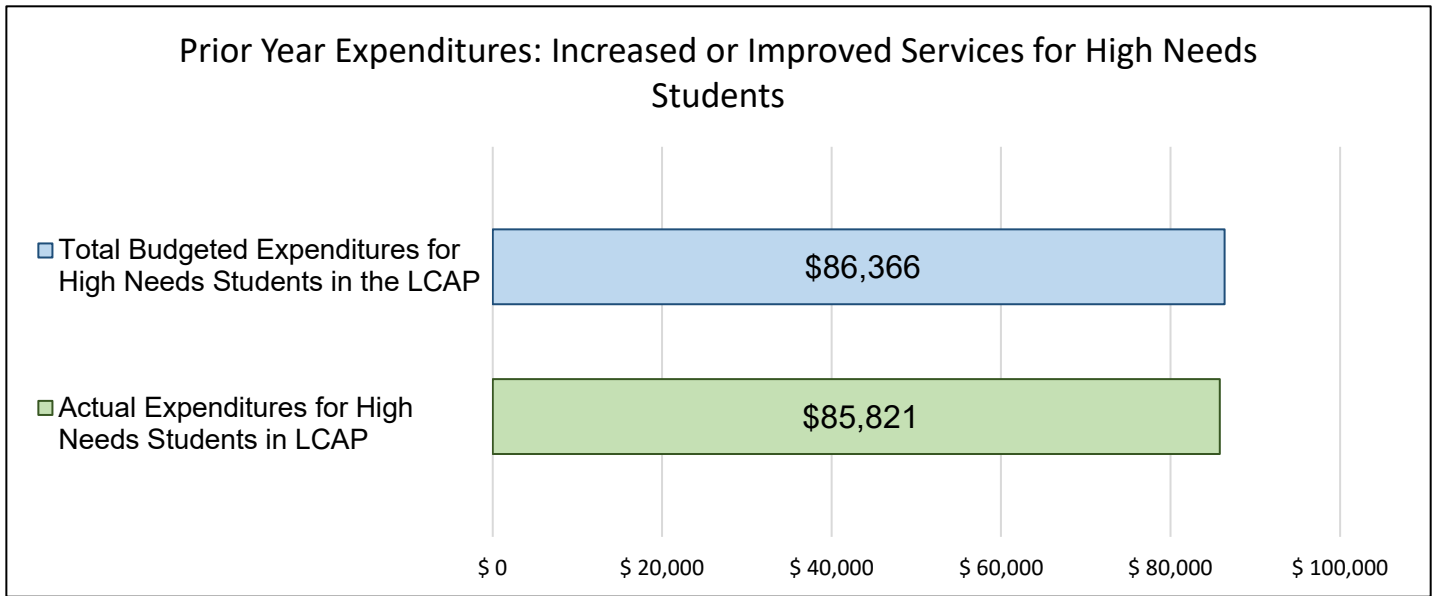

Increased or Improved Services for High Needs Students in the LCAP for the 2022 – 23 School Year

In 2022 – 23, Pleasant Grove JUSD is projecting it will receive \$83,135.00 based on the enrollment of foster youth, English learner, and low-income students. The district makes every effort to ensure all educational partners are invited to provide input in the development of all plans. To obtain input we use a combination of paper and on-line surveys, meetings, and posting of drafts on our website. We meet with our Site Council/Parent Advisory Group to review draft plans prior to presentation to the Governing Board. That process was followed in the development of these plans. We have successfully implemented the actions in our ESSER III plan during the 2021-22 school year and plan to use ESSER III funds to maintain these actions during the 2022-23 school year.

1. We have hired a 60% Intervention Specialist to provide intervention, monitor data, and oversee the intervention program to address the academic impact of lost instructional time with funds from our 2021-22 LCAP. We will use ESSER III funds to continue to fund this position for the 2022-23 school year.
2. School bus drivers are difficult to find, but we were able to hire one driver to provide transportation services to and from school for all in-district students and to designated stops for inter-district students to maintain the continuity of services to all students. We have not been able to hire a substitute driver. We will continue to use ESSER III funds during the 2022-23 school year to maintain transportation services.
3. We are maintaining safe, clean, and well-maintained facilities by hiring a part-time custodial/maintenance person to increase day-time cleaning to help reduce the spread of the COVID-19 virus. We will continue to use ESSER III funds during the 2022-23 school year to maintain these services.

Pleasant Grove JUSD is coordinating the use of the fiscal resources to best meet the needs of the district, staff, students, and community. All plans are primarily focused on addressing the academic impact of lost instructional time, supporting the social-emotional needs of students, families, and staff, and safely operating the school and all funds are budgeted to address those areas of need.

Plan Summary 2022/23

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Pleasant Grove Joint Union School District, located in rural south Sutter County, serves approximately 165 students in grades TK-8. Our student body is comprised of about 70% inter-district transfer students who come to us by choice due to our reputation for achievement and behavioral expectations. We accept all types of students for enrollment: students with behavioral problems, special education needs, or those who receive Title I services. The percentage of students who qualify for free and reduced breakfast and lunch is 31% currently. Our EL population is less than 3%.

The Pleasant Grove Joint Union School District (PGJUSD) has a rich history, traditional values, and progressive practices. As a learning community, we ardently believe failure is not an option and support our beliefs by putting effective practices into place. We are the only school in the Pleasant Grove School District. The school began serving students of the rural farming communities of South Sutter County in the mid 1800's, and many of our students' parents and grandparents, and even some of our current staff members, attended school here. We enjoy the many benefits of being a central part of a close knit, multigenerational farming community. Although we have strong roots in the past, we are a forward thinking, high quality school. Pleasant Grove students and staff all work hard and expect a lot of each other. We provide a unique educational experience, and everyone performs their best, no matter what their role.

We value strong, fundamental, standards-based education while employing innovative, engaging teaching techniques to meet the variety of learning needs and styles we encounter. We received Distinguished School Awards in 2008 and 2014 and a Title I Award in 2014. In 2016 we received the Gold Ribbon and Title I Awards. Never content to rest on our laurels, Pleasant Grove School continues to maintain a reputation of uncompromised commitment to academic growth.

Our vision is one of excellence in action and continuous learning, for all of us! We are not a complacent community of learners: everyone from community members to Board of Trustees to our custodians and bus drivers are integral to our success. We have partnerships with

community groups such as 4-H, Kiwanis Club, and the local fire department who provide services for our students. Our parents are very supportive of and involved in our school as Parents' Club members and classroom volunteers.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

The fall 2021 California School Dashboard only reflected Graduation and College/Career Indicators (CCI) which are not applicable to Pleasant Grove JUSD, therefore local data will be shared in this section.

Pupil Achievement: On winter 2022 local assessments, 40% of English learners scored Standard Met compared to 0% in 2021. We hired a 60% Intervention Specialist to monitor the academic achievement of students and coordinate interventions and supports to address the academic needs of all students including Socioeconomically Disadvantaged, English learners, foster youth (currently none), and students with disabilities. Approximately 45 students received Tier II or Tier III intervention. All unduplicated students and students with exceptional needs scoring Standard Not Met on ELA local assessments, received tiered intervention and for those students scoring Standard Not Met on Math local assessments, 86% received intervention. Eighty-six percent of students who participated in intervention say they believe it helped their learning and 97% of students say they received the support they need at school to be successful, an increase from 94% in 2021. Funding smaller classes, hiring an Intervention Specialist and additional support staff, and the use of data to drive instruction and intervention supported these successes and these actions will continue in Goal 1, Action 1.1, 1.2, and 1.4.

Pupil Engagement: Eighty-nine percent of students feel connected to the school. Students have enjoyed the return of assemblies, art instruction, and field trips. We are increasing our VAPA offerings through Goal 1, Action 1.5 and student engagement activities such as field trips, assemblies, and school spirit activities through Goal 2, Action 2.2.

Parent Involvement: We promoted parent engagement for parents of all student groups including unduplicated students and students with exceptional needs through regular communication. On a spring 2022 parent survey, 96% of parents feel the school is a friendly environment, an increase from 91.8% in 2021. Ninety-one percent of all parents say they have the opportunity to participate in decision making committees, an increase from 83.6% in 2021. Ninety-three percent of parents believe the school encourages them to be an active partner in educating their child. Parents say they receive information about what their child should learn and be able to do in each grade (89% in 2022 compared to 77% in 2021). Our efforts to increase parent engagement by increasing communication and engagement opportunities will continue with Goal 2, Action 2.1.

Local Indicators: Progress in several state local indicators was noted by our educational partners. In the local indicator, *Progress in Providing Professional Learning for Teaching to the Recently Adopted Academic Standards*, the academic area of Mathematics increased from 4 in 2021 to 5 on the rating scale (1-Exploration and Research Phase; 2-Beginning Development; 3-Initial Implementation; 4-Full Implementation; 5-Full Implementation and Sustainability). In the indicator, *Progress in Implementing Policies or Programs to Support in*

Identifying Areas Where They can Improve Delivering Instruction, three areas increased. ELD increased from 3 to 4; Mathematics from 4 to 5; and History-Social Science from 2 to 3. Goal 1, Action 1.1 includes professional development and will support continued progress.

Reflections: Identified Need

Pupil Achievement: There was a decline in percent of students meeting or exceeding on the CAASPP math assessment in 2021 compared to 2019: All students 53% in 2019, 33.33% 2021; Low-income students 41% in 2019, 23.33% in 2021. There was a similar decline in ELA for the All student group, 62% in 2019, 51.86% in 2021. There is a performance gap on our local assessment between the All student group and the Low-income student group in both ELA and Math. In ELA the All student group, 54% of students scored Standard Met compared to 32% of low-income students. In Math, 61% of all students scored Standard Met compared to 39% for the Low-income student group. Thirty-eight percent of parents believe their child will need academic support in the 2022/23 school year and 24% think their child may need support. Teachers report seeing results from our intervention program and support its continuation. Given the performance gaps and educational partner input we will fund staff to maintain small classes (Goal 1, Action 1.2) and an Intervention Specialist and support staff to support targeted intervention (Goal 1, Action 1.4). Fewer English learners made progress toward English proficiency as measured by the ELPAC (50% in 2019, 20% in 2021) and no students were reclassified. We will increase professional development including integrated ELD, Academic Vocabulary Toolkit (AVT), and mathematics in Goal 1, Action 1.1.

School Climate: On spring 2022 student surveys there was a slight decrease in student feeling of safety (85.2% in 2021 to 83.3% in 2022). Students also perceived bullying to be more of a problem, increasing from Yes 8% in 2021 to 9.8% in 2022 and Sometimes 25% in 2021 to 42.2% in 2022. School cleanliness, specifically the bathrooms, was rated low by students (27.2% say the school is not clean compared to 5.7% in 2021). There was very little change in parent survey results between 2022 and 2021. Slightly fewer parents said there was good two way communication 90.1% in 2021 to 87% in 2022. Through the actions in Goal 2 we will expand our methods of communication with families, increase our school spirit activities to encourage good attendance and good citizenship, continue funding a part-time school counselor and increase custodial time to improve school cleanliness.

Working with educational partners PGJUSD developed this LCAP to support the district's mission and vision.

Goal 1, *Ensure that all students are college and career ready by providing rigorous, relevant, and high-quality instruction that challenges all students and develops citizenship, leadership, and innovative thinking.*

Goal 2, *Enhance student engagement by providing enrichment activities, a positive and safe school climate, effective character education, and meaningful parent participation opportunities.*

Key features include: Maintaining an intervention program for students needing strategic and intensive intervention; Funding enough certificated staff to maintain small classes; Increasing professional development in the areas of integrated ELD, AVT, and mathematics; Further developing and coordinating a system that engages students and families; Increasing cleaning/maintenance services to improve the cleanliness of the facility.

Engaging Educational Partners

The district leadership staff began the process of reviewing progress on the current LCAP goals and actions in October 2021 and began gathering input from educational partners in March 2022 and this process continued throughout the development of the LCAP. The following educational partner meetings and surveys were used in the development of this document and considered before finalizing the LCAP.

Classified and Certificated Staff/Bargaining Unit: The Mid-Year LCAP, Budget Overview for Parents, and the LCAP Supplement was made available to staff. Staff completed surveys for Local Priorities 2 and 3 in March. Results of parent and student surveys was shared at an April 2022 meeting. The draft LCAP was available to staff for comment prior to final board approval. Staff members of our Site Council/LCAP Advisory Group participated in additional discussions regarding the progress on the current LCAP, data collected, proposed actions, and the draft 2022/23 LCAP during spring 2022 meetings.

Students: Students in grades 4th-8th were surveyed in March 2022 via Google forms for their input on conditions of learning, engagement, and academics. Results were used for the annual update as well as metrics to drive goals and actions for the 2022/23 LCAP.

Site Council/LCAP Advisory Group (No ELAC *fewer than 21 English learners*) and Parents: The Mid-Year LCAP, Budget Overview for Parents, and the LCAP Supplement was shared in March 2022. The Site Council/LCAP Advisory Group discussed draft goals and actions during the May 2022 meeting with final approval of the draft in late May. Meetings and the availability of surveys were publicized through email messages and posted on our website. Parent surveys were used to obtain data for the annual update as well as metrics to drive goals and actions for the 2022/23 LCAP.

SELPA: District leaders met with the Sutter County SELPA Director in April 2022 for input on the 2022/23 LCAP.

Board of Trustees: Throughout the year the board received updates on progress of goals and actions, data outcomes, and survey results. The Mid-Year LCAP, Budget Overview for Parents, and the LCAP Supplement was presented in March 2022. The draft LCAP was available on the district webpage for public comment prior to final board approval. Educational partners were encouraged to email the school to submit input. A Public Hearing of the draft LCAP was held on June 13, 2022. The LCAP was adopted on June 15, 2022.

A summary of the feedback provided by specific educational partners.

In developing LCAP goals and actions, feedback from all educational partners was analyzed. Input was synthesized into the following areas.

The Staff/Bargaining Unit felt that our focus needs to be on learning loss recovery and learning acceleration. Keep class sizes small so teachers can support struggling students. Readily available, actionable data is needed to offer differentiated and targeted support to students. The targeted intervention program with aides to support classroom and deliver Tier II and Tier III intervention and the addition of an Intervention Specialist have made a positive impact on student achievement. Social-emotional health of students and overall student behavior is a concern and will need support.

Students report that they miss after-school sports and school dances but are enjoying the assemblies and school activities that we have added. Students say they are getting the support they need from staff to be successful; students getting support, feel it is helping. Many students commented on the dirty bathrooms and the lack of cleanliness of the school in general.

Site Council/LCAP Advisory Group and Parents noted the desire for more advanced communication and they appreciate the additional activities we have added for students. Parents recognize the additional intervention and supports their children are receiving and want those to continue. After-school homework help was requested by many parents. Several parents noted the friendly, welcoming school climate.

Based on this input, metrics, goals, and actions were developed around two areas: student learning and student engagement/social-emotional health.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

PGJUSD actively sought the involvement and input of all educational partners as part of the 2022/23 LCAP development process and considered their input before finalizing the LCAP. The following summarizes the actions and services that have been influenced by specific educational partner input.

Educational partners noted the need to focus on learning loss recover and learning acceleration, maintain small class sizes, and continue our targeted intervention program. Parents recognize the additional intervention and supports their children are receiving and want those to continue. The following actions are a result of this input:

Goal 1, Action 1.2 Fund enough certificated staff to maintain single-grade classrooms.

Goal 1, Action 1.4 Monitor learning and deliver targeted intervention.

The social-emotional health of students and student engagement were commented on by educational partners and resulted in:

Goal 1, Action 1.5 Enrichment: Increase student access to visual and performing arts programs and courses by funding an instructor and materials for a six-week art instruction program.

Goal 2, Action 2.2 Increase student engagement and regular school attendance by offering varied opportunities for students to engage in school and learning.

Goal 2, Action 2.3 Support SEL needs of all students by funding a part-time school counselor and purchasing and implementing curriculum.

Many students remarked on the dirty bathrooms and the lack of cleanliness of the school in general. The following action is a result of this input:

Action 2.5 Improve the cleanliness of facilities by increasing custodial time.

An explanation of why the LEA has developed this goal.

There is a performance gap on our winter 2022 local assessment between the All student group and the Low-income student group in both ELA and Math. In ELA the All student group, 54% of students scored Standard Met compared to 32% of low-income students. In math, 61% of all students scored Standard Met compared to 39% for the Low-income student group. On the winter local reading assessment 31% of 3rd – 8th grade students scored Some Risk and 12% scored High Risk. On the winter local math assessment 31% of 3rd – 8th grade students scored Some Risk and 7% scored High Risk. Thirty-eight percent of parents believe their child will need academic support in the 2022/23 school year and 24% think their child may need support. Fewer English learners made progress toward English proficiency as measured by the ELPAC (50% in 2019, 20% in 2021) and no students were reclassified. Educational partner surveys indicate the need for focused professional development, especially in supporting struggling students and an increased need for targeted intervention.

The actions and services linked to this goal concentrate on instruction, academic performance, and interventions across the grade levels. These actions and services support the implementation of content standards and increasing achievement. Services are in place to support the implementation of content standards and improve access to the curriculum, including the academic success of unduplicated pupils.

Goal Analysis for 2021/22

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Successes: Nine classroom teachers were funded and teachers participated in extensive professional development in Academic Vocabulary Toolkit (AVT), learning loss and acceleration, and mathematics. (Action 1.1) We maintained small class sizes ranging from our smallest class with 13 students to our largest with 23 students. (Action 1.2) We purchased all planned standards-aligned instructional materials. (Action 1.3) The addition of a 60% Intervention Specialist and paraprofessional staff allowed us to offer a robust Tier II and Tier III intervention program to all students but especially to our Socioeconomically Disadvantaged, English learners, foster youth (currently none), and students with disabilities. (Action 1.4) Students in grades 1 – 8 participated in a six-week art instruction program led by our art docent. (Action 1.5) Teachers and students had 1:1 computer access and support for technology. (Action 1.6)

Challenges: Staffing shortages made it difficult to fill our paraprofessional positions but by December we were fully staffed. (Action 1.4)

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The district spent more than planned in Goal 1. There was a material difference between budgeted expenditures and estimated actual expenditures in Action 1.4 (Monitoring Learning and Intervention) due to increased personnel costs. There was some restructuring of classified positions and hours that resulted in an increase and the addition of an Intervention Specialist cost more than originally planned.

An explanation of how effective the specific actions were in making progress toward the goal.

Actions 1.1 (Certificated Staff/Professional Development), 1.2 (Certificated Staff to Reduce Class Sizes), 1.4 (Monitoring Learning and Intervention)

We maintained small class sizes ranging from our smallest class with 13 students to our largest with 23 students. An assessment system and regular intervention addressed students' individual learning needs. On Winter 2022 local assessments, 40% of English learners scored Standard Met compared to 0% in 2021. We hired a 60% Intervention Specialist to monitor the academic achievement of students and coordinate interventions and supports to address the academic needs of all students including Socioeconomically Disadvantaged, English learners, foster youth (currently none), and students with disabilities. Approximately 45 students (27%) received Tier II or Tier III intervention. All unduplicated students and students with exceptional needs scoring Standard Not Met on ELA local assessments, received tiered intervention and for those students scoring Standard Not Met on Math local assessments, 86% received intervention. Eighty-six percent of students who participated in intervention say they believe it helped their learning and 97% of students say they received the support they need at school to be successful, an increase from 94% in 2021. Eighty-seven percent of parents say their child receives the academic support needed to meet his/her individual needs.

Action 1.5 (VAPA)

An art docent provided a six-week art instruction program to all students in grades 1 – 8. Eighty-six percent of 4th-8th grade students report there are activities at school they enjoy participating in

Metrics Changes to Desired Outcome 2023/24 changes based on Year 1 Outcomes to metrics:

Implementation of State Standards *Percent of 3rd – 8th grade English learners scoring Standard Met in ELA on local assessment (FastBridge)*: The Year 1 Outcome was 40% and exceeded the Desired Outcome for 2023/24 so we increased the goal to >30%.

Pupil Achievement *Percent of students meeting and exceeding on CAASPP Summative Assessment (Grades 3-8)*: The Low-income student group surpassed the Desired Outcome for 2023/24 therefore the goal was increased to >65%.

Course Access *Percent of unduplicated and students with exceptional needs scoring Standard Not Met on local assessments, receiving tutoring or tiered intervention: Our Desired Outcome 2023/24 was 80%. The Year 1 Outcome rates (ELA: 100% and Math: 86%)*

This goal was developed to support the safety, engagement, and involvement of all educational partners. When parents were asked if they have been provided ways to be involved in school, 87% (82% in 2021) Strongly Agree/Agree and 91% (83.6% in 2021) of parents say they have the opportunity to participate in decision making committees. Regarding whether the school keeps parents well-informed about school activities, 87% Strongly Agree/Agree, a slight decrease from 90.1% in 2021. Ninety-four percent of parents say the school is a safe place and 83.3% of students said they feel safe at school and 11.8% of students said they sometimes feel safe at school. Fourteen percent of 4th-8th grade students say there are no activities they enjoy participating in at school. Our P2 attendance rate is 90% a decrease from 96.64% in 2021.

Thirty-one percent of our students are low-income and rely on home/school transportation and school meals. The actions in this goal are focused on creating and maintaining a positive school climate where everyone is encouraged to be an active participate in the school community.

Goal Analysis for 2021/22

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Successes: We regularly communicated with parents through email and social media. (Action 2.1) Various student engagement opportunities were offered such as Friday at the Flag, Read Across America, awards assemblies, Principal List lunch with the principal, Shady Creek for our 6th and 7th graders, whole school swim party, and numerous field trips. (Action 2.2) A part-time school counselor worked with students and provided lessons for teachers to use in class. (Action 2.3) Transportation to and from school was available for all in-district students and to designated stops for inter-district students. (Action 2.4)

Challenges: Due to COVID restrictions we limited parent visits to the campus in the fall, once restrictions eased in the spring we invited parents to Open House, Fridays at the Flag, and awards assemblies. (Action 2.1) Although we had cleaning staff, they were not able to keep the facilities as clean as in the past due to an increase in students deliberately making messes especially in the bathrooms. (Action 2.5)

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The district spent more in Goal 2 than planned. There was a material difference in Actions 2.4 (Transportation) and 2.5 (Safe, Clean Facilities) due to the increased cost of a bus driver/custodian and yard and outdoor maintenance services.

An explanation of how effective the specific actions were in making progress toward the goal.

Action 2.1 Parent Engagement

We promoted parent engagement for parents of all student groups including unduplicated students and students with exceptional needs through regular communication. On a spring 2022 parent survey, 96% of parents feel that the school is a friendly environment, an increase from 91.8% in 2021. Ninety-one percent of all parents say they have the opportunity to participate in decision making committees, an increase from 83.6% in 2021. Ninety-three percent of parents say the school encourages them to be an active partner with the school in educating their child. Parents say they receive information about what their child should learn and be able to do in each grade (89% in 2022, 77% in 2021).

Action 2.2 Student Engagement and Attendance

Eighty-nine percent of students feel connected to the school and 86.3% say there are activities at school that they enjoy participating in. Students have enjoyed the return of assemblies, art instruction, and field trips.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Metrics Changes to Desired Outcome 2023/24 changes based on Year 1 Outcomes to metrics:

Parent Involvement *Percent of parents who Strongly Agree/Agree, "I have opportunity to participate in decision making groups."*: The Year 1 Outcome for the All student group and the Low-income student group exceeded our Desired Outcomes 2023/24, therefore the goal was changed to >95% for both student groups.

Action Changes based on educational partner input and Year 1 Outcomes to metrics

2021/22 Action 2.5: *Continue to maintain safe, clean, and well-maintained facilities by funding current cleaning and contracted services and hiring a part-time maintenance person.*

- School cleanliness, specifically the bathrooms, was rated low by students (27.2% say the school is not clean compared to 5.7% in 2021). We will change action 2.5 to *Continue to maintain safe, clean, and well-maintained facilities by increasing custodial time.*

Pleasant Grove School will receive \$83,135 in supplemental funding for the 2022/23 school year based on the number and concentration of English learners, low income, and foster youth and does not qualify for concentration grant funding. A review of the district’s needs and metrics, along with educational partner input, determined that the following services and programs would be the most effective use of supplemental funds to meet the goals for unduplicated pupils. The following actions are principally directed and effective in increasing performance for low-income students, English learners, and foster youth.

A review of local assessment results shows a performance gap between our All student group and our unduplicated students. There is a performance gap on our local assessment between the All student group and the Low-income student group in both ELA and Math. In ELA the All student group, 54% of students scored Standard Met compared to 32% of low-income students. In Math, 61% of all students scored Standard Met compared to 39% for the Low-income student group. Thirty-eight percent of parents believe their child will need academic support in the 2022/23 school year and 24% think their child may need support. Data indicates unduplicated pupils are not recovering from pandemic-related learning loss at the same rate as the All student group. Fifty-five percent of our Tier II and Tier III intervention students are from our Unduplicated student group. In consideration of this performance gap and slower recovery rate, we are funding additional certificated staff to maintain small class sizes. Goal 1, Action 1.2.

This action is being provided on an LEA-wide basis and we expect that all students, but especially those scoring, Standard Not Met on local and state assessments, will benefit. Because of the gap in performance and slow rate unduplicated pupils have recovered from pandemic related learning loss, we believe this action will support our unduplicated pupils in recovering from learning loss significantly more than other students as measured by an increase in percent proficient on math universal assessments..

Pleasant Grove Joint Union School District is required to increase and improve services for unduplicated pupils by 5.91% The actions identified within the prompt above will be completed in order to meet this proportionality percentage.

Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [EC] Section 52064[e][1]). Purpose

 - This amount is the total of the Planned Percentage of Improved Services column

- 8. Total Estimated Actual Percentage of Improved Services (%)
 - This amount is the total of the Estimated Actual Percentage of Improved Services column
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)

- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
