Meetings were held with groups representing the community and Special Education administrators.

The draft of this plan was posted on our website and interested parties had an opportunity to provide feedback to the superintendent prior to adoption.

### A description of how the development of the plan was influenced by community input.

Pleasant Grove JUSD values its community and encourages meaningful stakeholder engagement. The district relies on stakeholder feedback to monitor programs and services as well as guide future planning efforts. Input received during the development of the ELO plan and LCAP was considered in the development of this plan. Listed below are priority themes that resulted from the ELO, LCAP, and ESSER III Plan community engagement efforts and influenced the development of the ESSER III Plan:

### **ELO**

- -Provide targeted intervention during non-core times during the school day
- -After-school tutoring
- -Cleaning/sanitizing facility

### **LCAP**

Parent Advisory Group (No ELAC), Parents/Guardians, and Community noted our work on school safety has been effective and should continue. They also noted the need for intervention for students and social-emotional support. Students and families do not feel as connected to school, so we need to increase engagement opportunities.

Classified and Certificated Staff/Bargaining Unit felt that our focus needs to be on learning loss recovery and learning acceleration. Smaller, single-grade classroom will support struggling students. Readily available, actionable data is needed to offer differentiated and targeted support to students. Targeted intervention during the school-day and after-school is needed and we need more staff and possibly a credentialed intervention teacher. Social-emotional health of students is a concern and will need support. Staff also noted the loss of the school-wide activities.

Students report that they missed the social aspects of school and the whole school activities we had. They missed the assemblies and Honor Roll and Principal's List activities.

### **SELPA**

-Universal assessments need to be administered to all students. Since SEL screening tools are new, establish cut points and tiers for support. Work with the school counselor on this process.

Stakeholder input across multiple plans stressed the need for universal assessments, academic intervention, additional staff to support students' academic and social-emotional needs. These priorities are being funded through our ELO plan and LCAP. Flat enrollment and shifting needs have necessitated a change in funding source for transportation and increased daily cleaning and maintenance. These actions were included in the 2021/24 LCAP but will instead be funded through ESSER III. In addition, ESSER III will fund the Intervention Specialist position for the 2022/23 school year.

  continuous and safe in-person learning and/or to addressing the impact of lost instructional time, the LEA may indicate that it is
  not implementing additional actions.
- Specify the amount of ESSER III funds the LEA plans to expend to implement the action(s); these ESSER III funds must be in addition to any funding for those action(s) already included in the plan(s) referenced by the LEA. ## **Ensuring Interventions are Addressing Student Needs**
